## Recommendations for Legs and Feet

## 1st Tranche Implementation Sites

The first stage of shortlisting to choose the sites to implement our lower limb recommendations is now complete, with second stage interviews to take place in the New Year. A huge thank you to everyone who has applied (the quality of all applications was impressively high) and a big congratulations to the 7 organisations who have been shortlisted. Our funding only allows us to initially support three sites but we are planning to develop a Community of Practice to share learning with from the three 1st tranche sites. More information about this will follow in 2021.

## Surgical Wounds Recommendations

Our NWCSPP recommendations for Surgical Wounds have been approved by the Board and are due to be sent to a graphic designer to create a final designed version and care pathway flowchart.



## E-Learning Modules

The free-to-access e-learning modules for the Essentials of Skin Assessment, Essentials of Wound Assessment and Essentials of Leg Ulceration are close to completion and due to be launched early in the New Year. The modules have been developed by Health Education England e-Learning for Healthcare, in partnership with the NWCSPP and Health Education England.

## Pressure Ulcer Data

The Data & Information workstream are working in collaboration with the National Patient Safety Team to develop a Pressure Ulcer dashboard for acute service providers, from the Hospital Episode Statistics data set, to replace the Safety Thermometer which is no longer being published. The plan is to share the draft dashboard with providers via the Regional Nursing teams in the New Year so that trusts have an opportunity to review and quality assure their data inputs and quality of coding before the move to national reporting from April 2021.

Work will commence in early 2021 to develop a similar dashboard for community providers from the Community Services Data Set.

## Supply and Distribution Workstream

Our Supply and Distribution workstream remains suspended until Spring 2021 to carry out vital work for the COVID-19 pandemic. We wish them every success.

## Wounds and Digital Imaging

Our Digital Imaging recommendations will be out for consultation in early 2021. These aim to provide guidance and information to increase the uptake of digital imaging ('photographs') for wound care.

Earlier this year, the NWCSPP won an industry award (a 'Woundie'!) from Wound Care Today for the Best Patient Engagement Campaign, awarded for the COVID-19 resources on the NWCSPP website.
